Whereas on the 16th May 1884 Thos. Davis obtained an order from the Superior Court of Davidson County to sell the land hereinafter described belonging to the minor heirs of William E. Hauser and whereas paid Thos. Davis Guardian of said minor heirs in presence of the authority granted in said order proceeded on the 4th day of August 1884 after due advertisement to sell said lands at public auction to the highest bidder when and where J. A. Sheek [#2213] became the last and highest bidder at the price of one hundred and thirty five dollars.

Now therefore the said Thomas Davis Guardian as aforesaid in consideration of the sum of one hundred and thirty five dollars to him in hand paid by J. A. Sheek the receipt whereof is hereby acknowledged has given granted, bargained sold and conveyed and by these presents does give grant bargain sell and convey unto the said J. A. Sheek his heirs and assigns the following described tracts of land lying and being in the County of Davidson on the waters of Yadkin River beginning at a stone and pointers the south east corner of lot No. 2 [?] on the line of lot No. 1 thence with said line S 50 E 10 1/2 poles to a stone, thence . . . containing 7 7/8 acres.

2nd lot wood land . . . in Sheek's line . . . near Lowder's corner . . . containing 5 3/4 acres.

To have and to hold the said land and premises to him the said J. A. Sheek his heirs and assigns forever.

In testimony thereof the said Thos Davis Guardian as aforesaid has hereunto set his hand and seal this 5th day of September 1884.

Whereas, by an order of the Superior Court of the County of Forsyth made on the 27 day of November 1883, Thos. Davis as admr of the estate of William E. Hauser, deceased, was licensed to sell and convey certain real estate of said deceased to pay debts and charges of administration, and whereas the said Thos Davis, after giving due public notice . . . did, on the 3rd day of March 1884 . . . to J. A.
